Pharmacy Student Corner – Personal Student Reflection on Rotations

I remember how anxious I was the very first day of pharmacy rotations. Sure, I had passed all of my assessments in P2 year, but I was still afraid of failing. All my knowledge was out the window! My preceptor assured me that all was as it should be: if I knew everything, then I didn't need to be on rotations. Since I was on rotations, then I had learned lots of things in the classroom, and I was there to learn how to apply my knowledge to real, live people.

It's been 12 weeks since that day, and I've completed rotations in Institutional Pharmacy and Adult Acute Care. My experience helped me extend empathy to stressed medical residents when they started their rotations July 1st. My experience also gave me the assurance to give therapeutic recommendations to the doctors. And they were so happy to receive them! Speaking of real, live people, my patients are feisty! A few groused about how many medications they are taking (not necessarily prescribed), and I seized the opportunity to talk to them about their diet and lifestyle, and what they are willing to change to be healthier.

I went into the room of one patient to discharge him, and he snapped, "What do you want?!" I replied, "To get your butt out of here!" He laughed.

Another patient showed me a card his daughter sent him. The front of the card said, "As you are recovering in the hospital, you'll be glad to know your doctor is using the latest technology." Inside, it says: "Her huge flat-screen plasma TV is hung perfectly in her living room." He was very proud of that card. I had a patient who initially seemed to be difficult because he was refusing his meds. I talked him into taking a couple since he was deficient in them and we were watching his serum levels closely. He was worried about doubling up on both the chewable and oral phosphate binder and he preferred the chewable one. He said the team agreed to not giving him a betablocker on the days he receives dialysis because his blood pressure would drop too low. Because I sat down and spent about 15 minutes with this patient, I also found out that he was feeling grumpy because he was about to have his foot (and perhaps his leg) amputated due to infection. I brought him a treat (diet soda).

It's been a whirlwind three months! I've rounded with doctors in ICU and the medical floor. I've hounded the technicians with questions in the IV room and about unit-dosing. I've sat in on conferences where I have very little understanding, and I've researched clinical trials and guidelines.

My friends and family are amazed at what I'm doing (they envision me handing out drugs at the outpatient window)—for them, as it is for us and our patients, the education continues.

NVSHP Legislative Committee – Current Affairs

The NVSHP Legislative Committee is actively seeking more volunteers. Time commitment will vary, but will mostly include monthly conference calls. Representatives from the North and South are encouraged. For more information, please email interest to Julie Rodgers (Julie.Rodgers@va.gov).

See below for highlights of the Legislative Committee efforts over the last quarter:

Board of Pharmacy Meetings

- July 16-17th in Las Vegas
 - > NVSHP participation included Katie Craven, Christina Madison and Shelly Spiro.
 - Pharmacists Practicing Outside a Pharmacy, updated Compounding regulations and Ambulatory Surgery Centers regulations have all been finalized by the Board. The regulations will be reviewed and potentially approved by the Legislative Council Bureau September 17th. If approved, all three regulations will go into effect September 18th.
 - August (no meeting)
 - September 3-4th in Reno

ASHP State Legislative Conference Calls

- Recent governmental affairs issues include:
 - O6/25/08 ASHP comments on the proposed NIOSH survey of healthcare workers' safety and health. ASHP's concern is that the complexity and length of the survey may limit participation; recommendations were to have participants complete the survey in stages to alleviate time-constraint burdens and to increase participation. Many other recommendations were provided on specific questions as well as to outline comprehensive definitions on terms, especially "hazardous drug" and "antineoplastic".
 - 07/03/08 ASHP comments on proposed resolution regarding transparency for patients in prescription drug care. ASHP requests clarification that this resolution is not intended to apply to hospital and health-care settings.
 - 07/07/08 ASHP comments on the FDA's Pilot Program to Evaluate Proposed Name Submissions concept paper. ASHP recommends that FDA specifically include other individuals in the example of a product prescribed by private practice oncologists be named, such as nurses working in private practices or others who might call in a prescription.
 - 07/23/08 ASHP requests clarification from CMS on interpretive guidelines sent to state surveyors regarding regulatory changes amending Hospital Conditions of Participation pertaining to requirements of history and physical examinations; authentication of verbal orders; securing medications; and post-anesthesia evaluations. Clarification seeking from CMS includes:
 - Orders for drugs and biological must be documented and signed by an authorized practitioner who is responsible for the care of the patient. The authorized practitioner may sign the patient's chart following the initiation of a protocol or standing order that has already been approved by the P&T Committee.
 - Therapeutic interchange of various drug products by pharmacists under arrangements where pharmacists and authorized prescribers interrelate on behalf of patient care is permitted when a hospital authorizes therapeutic interchange without a physician's order.
 - ASHP's Government Affairs Division has published another in the series on the value of clinical pharmacists: "Clinical Pharmacists Reduced, Avoided Expenditures". Abstract on the link: www.ashp.org/s ashp/docs/files/advocacy/policy alert/Economic Effects 7 28 08 .pdf
